6.3 OCP Amendment – Spectrum of Care

In discussion it was noted that:

- The Official Community Plan needs to create additional policy on seniors housing;
- District of Sechelt Community Planners are hoping to get feedback from the Accessibility Advisory Committee on seniors housing in regards to where they should get located, how they should be classified, and what sort of densities and amenities they should be near to;
- Assisted living is not just for seniors;
- Members of the Accessibility Advisory Committee expressed concern that if something becomes part of the Official Community Plan it could be restricting;
- Most, not all, care homes are licensed;
- The Official Community Plan should not define what type of support people get and where the care facilities should be located. Type of care received should be up to the individual, not the Official Community Plan;
- Assisted living care homes should be allowed to be built in rural areas and not just within the urban containment boundary;
- Assisted living should be built near bus stops and have easy access to transport;
- Assisted living care homes should not be built taller than the maximum height of a fire truck ladder;
- It was felt that the report was narrow minded, too focused on seniors, and contained ambiguous language (e.g. how "daily living" is used);
- Some members of the Accessibility Advisory Committee felt the District has no right to decide what type of service an individual receives in each unit of a care home;
- Nothing in report is finalized, no proposed bylaw amendment written yet, looking for ways to improve;
- The committee requested that they are able to review any draft bylaw before it

goes forward;

 Sunshine Coast Accessible and Adaptable Guideline brochure to be sent out in advance of the next meeting and added to the next committee agenda in February.

6.4 ICSP Advisory Committee Update

Due to loud construction noise on the roof of the building, this update was postponed until the next meeting.

6.5 Right Hand Signs on the Highway at Brookman

In discussion it was noted that:

- Concern was expressed regarding the location of the right hand turn sign at Brookman Park as its position is causing a hazard for pedestrians;
- Councillor Muller indicated he will discuss this with the Director of Engineering.
